Introduction

On 24 October 2017, the Association for European Border Regions (AEBR), together with the Nijmegen Centre for Border Research at the Radboud University, will organize the first edition of the "Cross Border School", as part of the Annual Event of the AEBR in Extremadura, Spain.

As a growing cross-border cooperation community "is haunting Europe and other continents" in terms of researchers, practitioners, and beneficiaries and an important amount of EU funds and national co-financing is devoted systematically to this type of cooperation every year, there is a stronger demand of for showcasing practises, results and impact.

The "Cross Border School" originates from the frequently perceived communication gap between science and practice, not only in terms of communicating research to professionals, but also in terms of feeding and feedback from professionals to academics. The mission of the "Cross Border School", therefore, is to create and nourish an environment where academics and professionals are equals, and share and learn from each other's experiences in a more horizontal, interactive manner.

For this first edition of this "Cross Border School", which is scheduled to become an annual event, the chosen broad theme is "Knowledge and Practice on the Border".

About the Nijmegen Centre for Border Research (NCBR)

In the dynamics of the internationalisation and globalisation geographical borders are more and more considered as challenges for further integration. At the same time however, borders still are considered to be relevant in many ways. Borders represent important values of identity of people and demarcate the sovereignty of governments. Because of this tension between borders as 'meeting-places' and borders as 'cut-off lines' borders have become maybe more important then ever before.

To deepen this theme theoretically and empirically in a broader and institutional context, the Nijmegen Centre for Border Research has been established in 1998.

The Nijmegen Centre for Border Research is also actively involved in encouraging the academic exploration of borders in the broadest sense through the co-editorship of Henk van Houtum and Martin van der Velde of the <u>Journal of Borderlands Studies</u> (JBS).

About the Association for European Border Regions (AEBR)

In line with its **statutes**, the AEBR works on behalf of the European border and cross-border regions with the aim to:

- highlight their special problems, opportunities, responsibilities and activities;
- represent their common interests vis-à-vis national and international parliaments, bodies, authorities and institutions;
- initiate, support and coordinate cooperation between the regions throughout Europe;
- promote exchanges of experience and information with a view to identifying and coordinating common interests among the diverse range of cross-border problems and opportunities, and to propose possible solutions.

About the Universidad de Extremadura

The UNIVERSITY OF EXTREMADURA was created in 1973 (Decree 991/1973, of May 10, 1973 BOE of May 18, 1973). Its history is intimately linked to the Extremadura community . Initially it was integrated by the Faculty of Sciences of Badajoz, the University College of Cáceres, the University Schools of the Faculty of EGB of Cáceres and Badajoz and the School of Agricultural Technical Engineering of Badajoz. Since then the UEx has increased its students, degrees and centers to have four spaces constituted by the campus of Badajoz , the campus of Cáceres , the University Center of Mérida and theUniversity Center of Plasencia

In the UEx they study more than 24,000 students of degree and postgraduate and another 8,000 they take courses of Doctorate, own titles or continuous formation. 1500 teachers work and more than 800 administrative staff, technicians and service staff. The Rector is D. Segundo Píriz Durán and the Government of the University is organized through different collegiate bodies, such as the Cloister and the Governing Council , and unipersonales like the Vicerrectorados , Management and General Secretariat .

About Borders In Globalization (B.I.G.)

Borders in Globalization (BIG) is an innovative, integrative, and sustainable network of academic partners from Canada, the United States, Europe, Asia, and the Middle East, which is engaged with non-academic organizations that are involved in the management of borders and borderlands in Canada and worldwide. Border studies are global in reach, and so we ground our core partnership in Canada and associate with key research centers worldwide. This provides support for a global policy-research agenda that serves Canadian interests.

The basic goal is to build excellence in the knowledge and understanding of borders. To this end, the partners will work together to create new policy and foster knowledge transfer in order to address such globalization forces as security, trade and migration flows, and also to understand the forces of technology, self-determination and regionalization that are affecting borders and borderlands in regions around the world.

Our program of research places Canadian scholars at the core of an international partnership, with the objectives of developing policy and knowledge from an international perspective and thus developing professional and academic training. A central tool to this end is *round-tables* between policy makers and academics that inform all our work from its inception; *Round-tables* lead to research, policy forums, summer schools, conferences, policy reports, briefs and books, and inform both theory and practice related to orders.

Since 2011, border studies knowledge has expanded in 'leaps and bounds'. Our proposed research develops the field significantly, is interdisciplinary across all social sciences, and is organized around a few critical themes that frame key discussions: self-determination, governance complexity, local culture, political clout, market and migration flows, and borders in motion. Policy makers, policy activists and social scientists need more than the existing partial – narrowly defined or territorially limited - explanations of border issues that are available. They need to go beyond, for example, the study of the internal and external borders of the European Union or the study of the maritime borders of Japan. This proposed research program moves the field forward by developing a *global* scholarship to theoretical conceptual thinking on borders, while privileging the practical issues that policy-makers face daily.
